- Registration of first legal mortgage over the property to be financed
 - Personal guarantee of the spouse (if not a co-borrower to the loan)
 - Assignment of life insurance of the borrower for the value and duration of the loan
 - Fire and earthquake insurance with mortgage clause in relation to the property
 - Contractors All Risk insurance with mortgage clause in relation to the building to be constructed on the property
 - Any other securities that may be requested by the Bank
3. The borrower has the right to withdraw from the loan agreement within 5 working days from the signing thereof, provided no amount has been disbursed under the said loan agreement.
 4. This product is available only to Cyprus permanent residents who have a Cypriot citizenship. Non-permanent residents and non-Cypriot Residents may apply for a housing loan eligible for interest rate subsidy by the government according to terms and conditions set by the Bank. In all cases, income criteria apply for the acceptable of customers in line with the Bank's customer acceptance policy.
