The apartment is part of the seven-storey apartment building "Sandy Beach Apts A" (which falls within the urban planning zone Ka3), which was erected in 1987 and consists of two mixed-use blocks, one on the northern border of the plot and one on the southern border of the plot, each with an uncovered parking space, five shops and three apartments on the ground floor and fifty-two apartments on the six vertical floors. The wider area is residential / touristic in nature and is characterized by apartment complexes and public use properties (school, restaurants).
